



FORT WORTH TERMS, CONDITIONS & PAYMENT INSTRUCTIONS

- 1) The Buyer acknowledges that Buyer has read and agrees to be bound by the auction terms as well as all other terms and conditions set forth in the Buyer Registration Agreement, Auction Catalog, Auction Invoice, Bill of Sale and all other written or electronic terms and conditions provided by Taylor & Martin, Inc. (T&M) in connection with this sale. Any verbal or written announcements of T&M or the auctioneer on the date of sale shall take precedence over any other written or electronic terms to the contrary.
- 2) **INTERNET FEES BEING WAIVED DUE TO COVID-19 VIRUS, PLEASE BID ONLINE.** ~~A 2.5% Internet Purchase Fee will be charged on all online purchases up to \$40,000.00. Any purchases exceeding \$40,000.00 will be charged a flat rate of \$1,000.00 per unit. A 2% Transaction Fee will also be charged.~~
