To register you will need a valid photo ID and a **\$250 cash deposit**. Deposits for unsuccessful bidders will be returned in the same form when exiting. **Full payment is due at the end of the auction.**

Online Simulcast: Register at www.txauction.com. Click the blue proxibid.com logo on our website homepage and complete the registration form. Then submit a **\$1,000 deposit**. Deposit must be received at Gaston & Sheehan NLT Friday, November 13th at 5:00 p.m. CST. **PreBids:** You must be registered with proxibid.com and approved for the online simulcast auction. Pre-bids can be made now and throughout the auction. You can enter a low and high bid for each lot. Your bid will increase as you are bid against.

Full payment is due NLT 3 days after the auction. Deposits for unsuccessful bidders will be returned by company check the week after the auction.

Absentee Bids: Written bids will be accepted until Friday, November 13th at 5:00 P.M. CST. **A \$1,000 deposit is required before bids will be accepted. Full payment is due NLT 3 days after the auction.** Deposits for unsuccessful bidders will be returned by company check. This may take seven to ten days.
